SINCE THEN, THE INSTITUTE HAS BECOME A NATIONAL LEADER IN BREAST CANCER PREVENTION THROUGH ENVIRONMENTAL HEALTH RESEARCH AND THE STUDY OF ENDOCRINE DISRUPTING COMPOUNDS ("EDCS") AND THEIR INFLUENCE ON THE DISEASE.
